



REQUEST FOR PERMIT FOR PHOTOGRAPHING AIRCRAFT

Person engaged in aviation photography (hereinafter: the Person):

- is obliged to fill in this Request and send the signed copy to the e-mail address bedzevi@zag.aero
- after the issuance of the Permit for photography (hereinafter: the Permit), will receive information by e-mail within seven (7) days whether the Permit has been issued. A certified copy of the Permit is stored in the Administrative Affairs, the Badge Issuing Office, and the other is delivered to the Person
- will be registered on the list of persons (spotters) who are allowed to photograph the aircraft, and which is kept by MZLZ - Zagreb Airport Operator Ltd. for a period of three years
- may photograph aircraft only from certain places along the fence of the Franjo Tuđman Airport (hereinafter: The Airport) approved by the Airport Security Committee. Positions for photography are marked on the map which is an integral part of this Application.

Terms used in this Request that have a gender meaning are used neutrally and refer equally to the masculine and feminine genders.

Upon receipt of the Permit, I confirm that I am aware that:

1. on the day of arrival, I must announce my arrival at the Franjo Tuđman Airport area with a precisely defined position for photography on the telephone number 01/4562 535,
2. after finishing the photo shoot, i.e. leaving the place where the photo was taken, I must inform that I am leaving the place where the photo was taken on the phone number 01/4562 535
3. I can use for photography only the positions marked with numbers from 1 to 6 on the map which is an integral part of this form
4. I cannot access places that are not designated as permitted for photography
5. I cannot climb on the wire of the protective fence
6. I cannot lean my ladder on the guardrail, nor place it closer than 1,5 meters from the guardrail
7. I must follow all the instructions that will be in force at the time I want to take photos, in the area and around the area of The Airport, and about which I will be informed when answering the phone number 01/4562 535
8. if I notice any damage to the guardrail or an attempt by unauthorized persons to cross the guardrail, I must immediately notify about the event on the telephone number 01/4562 535
9. at the request of the authorized person performing security tasks at The Airport, I am obliged to show my identity card or passport, by which the authorized person will establish my identity
10. any non-compliance with these rules will result in unilateral termination of the Permit, which shall take effect from the moment I am notified by e-mail and that from that moment I will be prohibited from accessing The Airport guardrail
11. MZLZ - Zagreb Airport Operator Ltd. reserves the right to unilaterally cancel the Permit, which comes into force from the moment I am notified by e-mail, and that from that moment I have a ban on access to The Airport guardrail
12. when recording and publishing recorded materials, I must respect all applicable rights of natural and legal persons that I have photographed, i.e. I know I may not photograph natural persons.



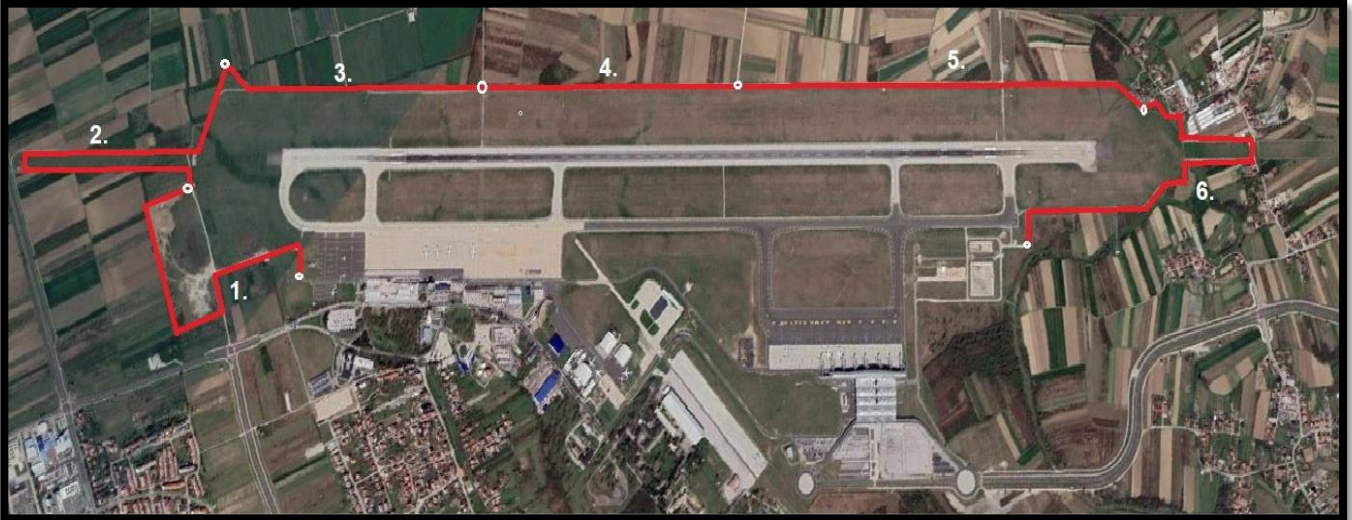
REQUEST FOR PERMIT FOR PHOTOGRAPHING AIRCRAFT

I confirm that I am aware that my personal data contained in this Form are collected and processed exclusively for the purpose of issuing a Permit for photographing aircraft and for the purpose of preventing unauthorized access to the airside area, in accordance with the requirements of the National Civil Aviation Program and Franjo Tuđman Airport Protection Program. The collected data will be kept for one (1) year from the date of termination of the Permit, or one (1) year after the cancellation or termination of the Permit. Furthermore, I know that at any time I have the right to request information about what personal data is processed, and to request the right to access and correct my personal data. If applicable, I may request a restriction on the processing and deletion of my personal data. If I believe that any of my rights have been violated, I can file a complaint to the Agency for Personal Data Protection, Martićeva ulica 14, 10 000 Zagreb, or e-mail address azop@azop.hr. Requests, complaints or inquiries related to the processing and protection of personal data can be sent to the e-mail address DPO@zag.aero or in writing to the address: MZLZ - Zagreb Airport Operator Ltd., Ulica Rudolfa Fizira 1, 10410 Velika Gorica.
