



The success of the "Standards Replacements" program lies on a highly effective circular flow from the purchase of a REMAN product to the return of the used part (or defective material)



CMANITOU PARTS

The used part must comply with the following conditions for its validation:

- Complete part
- Not disassembled
- No external damage (impact, cracks...)
- No corrosion
- All parts must be properly packed in the original REMAN packaging, or with the original bottom support for handling.
- In good return conditions: thoroughly drained and cleaned
- All part must have a tracking label (sent with the Manitou REMAN part)

We will perform a comprehensive analysis to validate product return conditions, and we will **reimburse the deposit in no later than six weeks** after its reception.

The conditions below apply to all Manitou REMAN parts:

• NON-ABRASIVE CLEANING

The used part must not be cleaned using abrasive techniques (abrasive blasting or microblasting). The guarantee will not be reimbursed if a critical area of the item has been damaged due to an abrasive process.





DISASSEMBLED PART



Spare parts may be disassembled only for diagnostic or fault analysis purposes. If an item is disassembled, it must be put back together with all genuine parts before delivery.

Disassembled parts have a higher risk of corrosion or missing components. This may result in the guarantee not being reimbursed. The guarantee will not be reimbursed if there is a component that is not a Manitou genuine part.

• ATTEMPTED REPAIR

Any attempt to repair a component will not be accepted- Please refer to the relevant data sheets for further information.

• NON-OPERATIONAL DAMAGES

The guarantee will not be reimbursed if used parts are damaged due to incorrect handling, corrosion, rust or fire.

Similarly, the guarantee will not be reimbursed due to incorrect or lack of maintenance or vandalism, which may seriously deteriorate the sub-components of the spare part beyond repair.

• PACKAGING

The client who has ordered a REMAN spare part is responsible for the packaging of the core. The core must be returned in the original packaging of the remanufactured part, in good conditions without deterioration. If the original package is no longer available, the client must pack the item in an adequate package to avoid damages during transport.

If the core is damaged due to improper packaging, as detailed in section "NON-OPERATIONAL DAMAGES" above, the guarantee will not be reimbursed.

Certain products are sent with bottom supports for handling purposes (as detailed in the following pages). If these supports are not returned or if they are deteriorated, the guarantee will not be reimbursed.

CORE RETURN

When you buy a Manitou REMAN product or standard replacement, the reference number for the part includes the acronyms E.S or ESA for Manitou. The REMAN product is sent to you with two identical "return labels".

• Returning used parts:

All orders for REMAN by Manitou parts must be returned within 6 weeks. Transportation costs for this return are at the dealer's expense.

1- Fill-in and include IMPERATIVELY these two labels. One must be sticked outside the parcel, and must be readable. The second one must be inserted inside the parcel.

DEPOSIT REIMBOURSEMENT

1- Deposit invoice

When you buy a Manitou REMAN part, you are invoiced for the reman part + a deposit that will be reimbursed after receiving and testing the used part (which you must send to us within the requested timeframe).

2- Quality control for used parts:

Manitou applies a strict quality control process for used parts to validate compliance with return criteria.



→ Certain parts require additional controls to be carried by you before their return. For further details on the aspects to comply with for each product family, please refer to the relevant DATA SHEET.

3- Deposit reimbursement through credit note:

Manitou will send you a positive (credit note) or negative (refusal to remanufacture) response within 6 weeks after receiving the core.



- → The deposit amount depends on each product family. Please refer to the relevant **DATA SHEET** for the exact amount.
- → If, following the quality control process, we verify that the return criteria have not been fulfilled, we will inform you by email that the core has been set aside for you to pick it up.
 A credit note will not be issued. Following that timeframe, Manitou will destroy the core.
