Article 441-7 of the Penal Code punishes with one year of imprisonment and a fine of 15,000 euros, the fact of making use of an inaccurate or falsified certificate. These penalties are increased to three years' imprisonment and a fine of 45,000 euros if this offence is committed with a view to damaging the assets of another person.


